Release of All Claims

2. Authorization and permission is hereby given to said church to furnish any necessary transportation, food, and lodging for this participant.
3. We (I) agree(s) to hold harmless and indemnify said church, its directors, employees, and agents, for any liability sustained by said church as the result of the negligent, willful, or intentional acts of said participant, including expenses incurred attendant thereto.
